## **Completion of Placement**

MacPhersons Resources Limited (“the **Company**”) (ASX : **MRP**) advises that the first tranche of the Company's placement to raise \$2.93 million (before costs) announced on 11 September 2017 has settled today and the Company has issued 17,302,903 Shares at an issue price of \$0.13. The balance of Placement shares will be issued following receipt of cleared funds by the Company.

The placement utilised the Company's available capacity under ASX Listing Rule 7.1, and accordingly, no shareholder approval was required for the Placement. Bell Potter Securities Limited and Patersons Securities Limited were Joint Lead Managers to the Placement.
